Natural Resource Data & Information:

- **EPA water quality assessment**
Washington's Water Quality Assessment lists the water quality status for water bodies in the state. This assessment meets the federal requirements for an integrated report under Sections 303(d) and 305(b) of the Clean Water Act. The assessed waters are grouped into categories that describe the status of water quality. The 303(d) list comprises those waters that are in the polluted water category, for which beneficial uses– such as drinking, recreation, aquatic habitat, and industrial use – are impaired by pollution.

By 2019, the FCD will have begun restoration of Curlew Creek at the confluence with Curlew Lake.
